# EXISTENCE OF SOLUTIONS FOR A VARIABLE EXPONENT SYSTEM WITHOUT PS CONDITIONS

& \text { ABSTRACT. In this article, we study the existence of solution for the following } \\
& \text { elliptic system of variable exponents with perturbation terms } \\
& \left.-\operatorname{div}|\nabla u|^{p(x)-2} \nabla u\right)+|u|^{p(x)-2} u=\lambda a(x)|u|^{\gamma(x)-2} u+F_{u}(x, u, v) \quad \text { in } \mathbb{R}^{N}, \\
& \left.-\operatorname{div}|\nabla v|^{q(x)-2} \nabla v\right)+|v|^{q(x)-2} v=\lambda b(x)|v|^{\delta(x)-2} v+F_{v}(x, u, v) \quad \text { in } \mathbb{R}^{N}, \\
& u \in W^{1, p(\cdot)}\left(\mathbb{R}^{N}\right), v \in W^{1, q(\cdot)}\left(\mathbb{R}^{N}\right),
\end{aligned}

where the corresponding functional does not satisfy PS conditions. We obtain a sufficient condition for the existence of solution and also present a result on asymptotic behavior of solutions at infinity.

## 1. Introduction

The study of differential equations and variational problems with variable exponent has attracted intense research interests in recent years. Such problems arise from the study of electrorheological fluids, image processing, and the theory of nonlinear elasticity [1, 7, 19, 26]. The following variable exponent flow is an important model in image processing [7]:

The main benefit of this flow is the manner in which it accommodates the local image information. We refer to [14, 18, 24] for the existence of solution of variable exponent problems on bounded domain.

In this article, we consider the existence of solutions for the system

[^0]where $p, q \in C\left(\mathbb{R}^{N}\right)$ are Lipschitz continuous and $p(\cdot), q(\cdot) \gg 1$, the notation $h_{1}(\cdot) \gg h_{2}(\cdot)$ means ess $\inf _{x \in \mathbb{R}^{N}}\left(h_{1}(x)-h_{2}(x)\right)>0$,

\left.-\Delta_{p(x)} u:=-\operatorname{div}|\nabla u|^{p(x)-2} \nabla u\right)

which is called the $p(x)$-Laplacian. When $p(\cdot) \equiv p$ (a constant), $p(x)$-Laplacian becomes the usual $p$-Laplacian. The terms $\lambda a(x)|u|^{\gamma(x)-2} u$ and $\lambda b(x)|v|^{\delta(x)-2} v$ are the perturbation terms. The $p(x)$-Laplacian possesses more complicated nonlinearities than the $p$-Laplacian (see [15]). Many methods and results for $p$-Laplacian are invalid for $p(x)$-Laplacian.

The PS condition is very important in the study of the existence of solution via variational methods. According to [21, Theorem 2.8], if a $C^{1}(X, \mathbb{R})$ functional $f$ satisfies the Mountain Pass Geometry, then it has a PS sequence $\left\{x_{n}\right\}$ which satisfies $f\left(x_{n}\right) \rightarrow c$ which is the mountain pass level and $f^{\prime}\left(x_{n}\right) \rightarrow 0$. By [21, Theorem 2.9] it follows that if $f$ also satisfies the PS condition, passing to a subsequence, then $x_{n} \rightarrow x_{0}$ in $X$, and then $x_{0}$ is a critical point of $f$, that is $f^{\prime}\left(x_{0}\right)=0$. In the study of this problems in the bounded domain, since we have the compact embedding from a Sobolev space to a Lebesgue space, so we have the PS condition when we study the case of subcritical growth condition. For the unbounded domain, we cannot get the compact embedding in general, so we do not have the PS condition.

It is well known that a main difficulty in the study of elliptic equations in $\mathbb{R}^{N}$ is the lack of compactness. Many methods have been used to overcome this difficulty. One type of methods is that under some additional conditions we can recover the required compact imbedding theorem, for example, the weighting method [16, 25], and the symmetry method [23]. If equations are periodic, the corresponding energy functionals are invariant under period-translation. We refer to [2]-5] and references cited therein for the applications of this method to the $p$-Laplacian equations, the Schrödinger equations and the biharmonic equations etc.

Sometimes we can compare the original equation with its limiting equation at infinity. Especially, we can compare the corresponding critical values of the functionals for these two equations when the existence of the ground state solution for the limiting equation is known. Usually the limiting equations are homogeneous, but in [2]-5] the limiting equations are periodic. We also refer to [13] for the existence of solution for $p(x)$-Laplacian equations with periodic conditions.

In this article we consider the existence and the asymptotic behavior of solutions near infinity for a variable exponent system with perturbations that does not satisfy periodic conditions, which implies the corresponding functional does not satisfy PS conditions on unbounded domain. We will also give a sufficient condition for the existence of solutions for the system 1.1). Our method is to compare the original equation with its limiting equation at infinity without perturbation. These results also partially generalize the results in [13] and [20].

In this article, we make the following assumptions.
(A0) $p(\cdot), q(\cdot)$ are Lipschitz continuous, $1 \ll p(\cdot), q(\cdot) \ll N, 1 \ll \gamma(\cdot) \ll$ $p(\cdot), a(\cdot) \in L^{\frac{p(\cdot)}{p(\cdot)-\gamma(\cdot)}}\left(\mathbb{R}^{N}\right), 1 \ll \delta(\cdot) \ll q(\cdot), b(\cdot) \in L^{\frac{q(\cdot \cdot)}{q(\cdot)-\delta(\cdot)}}\left(\mathbb{R}^{N}\right), F$ $\in C^{1}\left(\mathbb{R}^{N} \times \mathbb{R}^{2}, \mathbb{R}\right)$ satisfies

where $\varepsilon(R)$ satisfies $\lim _{R \rightarrow+\infty} \varepsilon(R)=0$.
This article is organized as follows. In Section 2, we introduce some basic properties of the Lebesgue-Sobolev spaces with variable exponents and $p(x)$-Laplacian. In Section 3, we give the main results and the proofs.

## 2. Notation and preliminary results

Throughout this paper, the letters $c, c_{i}, C_{i}, i=1,2, \ldots$, denote positive constants which may vary from line to line but are independent of the terms which will take part in any limit process. To discuss problem (1.1), we need some preparations on space $W^{1, p(\cdot)}(\Omega)$ which we call variable exponent Sobolev space, where $\Omega \subset \mathbb{R}^{N}$ is an open domain. Firstly, we state some basic properties of spaces $W^{1, p(\cdot)}(\Omega)$ which we will use later (for details, see [9, 11, 12, 14]). Denote

Proposition 2.1 ([9]). (i) The space $\left(L^{p(\cdot)}(\Omega),|\cdot|_{p(\cdot), \Omega}\right)$ is a separable, uniform convex Banach space, and its conjugate space is $L^{p^{0}(\cdot)}(\Omega)$, where $\frac{1}{p(x)}+\frac{1}{p^{0}(x)} \equiv 1$.
For any $u \in L^{p(\cdot)}(\Omega)$ and $v \in L^{p^{0}(\cdot)}(\Omega)$, we have

(2) $\lim _{n \rightarrow \infty} \rho\left(u_{n}-u\right)=0$;
(3) $u_{n} \rightarrow u$ in measure in $\Omega$ and $\lim _{n \rightarrow \infty} \rho\left(u_{n}\right)=\rho(u)$.

Denote $Y=\prod_{i=1}^{k} L^{p_{i}(\cdot)}(\Omega)$ with the norm

(i) For a.e. $x \in \Omega, y \rightarrow f(x, y)$ is a continuous function from $\mathbb{R}^{k}$ to $\mathbb{R}^{m}$,
(ii) For any $y \in \mathbb{R}^{k}, x \rightarrow f(x, y)$ is measurable.

If there exist $p_{1}(\cdot), \ldots, p_{k}(\cdot) \in C_{+}(\bar{\Omega}), 1 \leq \beta(\cdot) \in C(\bar{\Omega}), \rho(\cdot) \in L^{\beta(\cdot)}(\Omega)$ and positive constant $c>0$ such that

It is easy to see that the norm $\|\cdot\|_{p(\cdot), \Omega}^{\prime}$ is equivalent to $\|\cdot\|_{p(\cdot), \Omega}$ on $W^{1, p(\cdot)}(\Omega)$, and $\|\cdot\|_{q(\cdot), \Omega}^{\prime}$ is equivalent to $\|\cdot\|_{q(\cdot), \Omega}$ on $W^{1, q(\cdot)}(\Omega)$. In the following, we will use $\|\cdot\|_{p(\cdot), \Omega}^{\prime}$ instead of $\|\cdot\|_{p(\cdot), \Omega}$ on $W^{1, p(\cdot)}(\Omega)$, and use $\|\cdot\|_{q(\cdot), \Omega}^{\prime}$ instead of $\|\cdot\|_{q(\cdot), \Omega}$ on $W^{1, q(\cdot)}(\Omega)$. We denote by $W_{0}^{1, p(\cdot)}(\Omega)$ the closure of $C_{0}^{\infty}(\Omega)$ in $W^{1, p(\cdot)}(\Omega)$.

Proposition 2.6 ([8, 9, 11]). (i) $W^{1, p(\cdot)}(\Omega)$ and $W_{0}^{1, p(\cdot)}(\Omega)$ are separable reflexive Banach spaces;
(ii) If $p(\cdot)$ is Lipschitz continuous, $\alpha(\cdot)$ is measurable, and satisfies $p(\cdot) \leq \alpha(\cdot) \leq$ $p^{*}(\cdot)$ for any $x \in \Omega$, then the imbedding from $W^{1, p(\cdot)}\left(\mathbb{R}^{N}\right)$ to $L^{\alpha(\cdot)}\left(\mathbb{R}^{N}\right)$ is continuous;
(iii) If $\Omega$ is bounded, $\alpha \in C_{+}(\bar{\Omega})$ and $\alpha(\cdot)<p^{*}(\cdot)$ for any $x \in \bar{\Omega}$, then the imbedding from $W^{1, p(\cdot)}(\Omega)$ to $L^{\alpha(\cdot)}(\Omega)$ is compact and continuous.

We denote $\|\cdot\|_{*},\|\cdot\|_{*, p(\cdot)}$ and $\|\cdot\|_{*, q(\cdot)}$ the norms of $X^{*},\left(W^{1, p(\cdot)}\left(\mathbb{R}^{N}\right)\right)^{*}$ and $\left(W^{1, q(\cdot)}\left(\mathbb{R}^{N}\right)\right)^{*}$, respectively. Obviously $X^{*}=\left(W^{1, p(\cdot)}\left(\mathbb{R}^{N}\right)\right)^{*} \times\left(W^{1, q(\cdot)}\left(\mathbb{R}^{N}\right)\right)^{*}$ and

Theorem 2.9. $\Psi_{1} \in C^{1}(X, \mathbb{R})$ and $\Psi_{1}, \Psi_{1}^{\prime}$ are weakly-strongly continuous, that is, $\left(u_{n}, v_{n}\right) \rightharpoonup(u, v)$ implies $\Psi_{1}\left(u_{n}, v_{n}\right) \rightarrow \Psi_{1}(u, v)$ and $\Psi_{1}^{\prime}\left(u_{n}, v_{n}\right) \rightarrow \Psi_{1}^{\prime}(u, v)$.

The proof is similar to the proof of [25, Theorem 3.2], we omit it here.

## 3. Main results and their proofs

In this section, we state the main results at first, and using the critical point theory, we prove the existence of solutions for problem (1.1), and the asymptotic behavior of solutions near infinity.

We say that $(u, v) \in X$ is a weak solution for 1.1), if

It is easy to see that the critical point of $J$ is a solution for 1.1).
Similar to the proof of [18, Theorem 5], from (A1) we have

& J^{\infty}=\inf _{(u, v) \in \mathcal{N}} \widehat{J}(u, v) .

Now our results can be stated as follows.
Theorem 3.1. If $F$ satisfies (A0)-(A3), the positive parameter $\lambda$ is small enough and $c<J^{\infty}$, then 1.1 possesses a nontrivial solution.

Next, we give an application of Theorem 3.1. that is, a sufficient condition for $c<J^{\infty}$.

We say $h(x)$ is periodic and its period is $A=\left\{a_{1}, a_{2}, \ldots, a_{N}\right\}$ where $a_{i} \geq 0$, $1 \leq i \leq N$, if

Theorem 3.2. If $p(\cdot), q(\cdot)$ are periodic and their periods is $A, F(x, s, t)$ satisfies (A0)-(A3), and there exist $\tau, \delta>0$ and $p(\cdot) \ll \alpha_{o}(\cdot) \ll p^{*}(\cdot), q(\cdot) \ll \beta_{o}(\cdot) \ll$ $q^{*}(\cdot)$ such that

then (1.1) possesses at least one nontrivial solution when $\lambda$ is small enough.
Next we give the behavior of solutions near infinity.
Theorem 3.3. Suppose (A0)-(A3) hold, $a, b \in L^{\infty}\left(\mathbb{R}^{N}\right)$. If $u$ is a weak solution for problem (1.1), then $u, v \in C^{1, \alpha}\left(\mathbb{R}^{N}\right), u(x) \rightarrow 0,|\nabla u(x)| \rightarrow 0, v(x) \rightarrow 0$ and $|\nabla v(x)| \rightarrow 0$ as $|x| \rightarrow \infty$.
3.1. Proof of Theorem 3.1. For the proof, we need to do some preparations.

Lemma 3.4. If $F$ satisfies (A0)-(A2), and the parameter $\lambda$ is small enough, then $J$ satisfies the Mountain Pass Geometry, that is,
(i) There exist positive numbers $\rho$ and $\alpha$ such that $J(u, v) \geq \alpha$ for any $(u, v) \in$ $X$ with $\|(u, v)\|=\rho$;
(ii) $J(0,0)=0$, and there exists $(u, v) \in X$ with $\|(u, v)\|>\rho$ such that $J(u, v)<$ 0 .

Proof. (i) Recall that (A0)-(A1) imply (A0'). Then from (A0') we have

& -\varepsilon \int_{\mathbb{R}^{N}}\left[|u|^{p^{+}}+|v|^{q^{+}}\right] d x-C(\varepsilon) \int_{\mathbb{R}^{N}}\left(|u|^{\alpha(x)}+|v|^{\beta(x)}\right) d x \\
\geq & \frac{1}{2} \Phi(u, v)-C(\varepsilon) \int_{\mathbb{R}^{N}}\left(|u|^{\alpha(x)}+|v|^{\beta(x)}\right) d x .
\end{aligned}

Since $p$ is Liptchitz cntinuous, we can divide $\mathbb{R}^{N}$ into countable disjoint cube $\Omega_{n}, n=1,2, \ldots$, each one has the same side length, such that $\cup_{n=1}^{\infty} \Omega_{n}=\mathbb{R}^{N}$ and for any $n=1,2, \ldots$, the following inequalities hold

Denote $\alpha_{\Omega_{n}}^{-}=\inf _{x \in \Omega_{n}} \alpha(x), p_{\Omega_{n}}^{+}=\sup _{x \in \Omega_{n}} p(x)$. Suppose the positive number $\rho<1$ is small enough and $\|(u, v)\|=\rho$, from Propositions 2.3 and 2.6 it follows that

& +\frac{1}{2} \sum_{n=1}^{\infty} \int_{\Omega_{n}} \frac{1}{q(x)}\left(|\nabla v|^{q(x)}+|v|^{q(x)}\right) d x \\
& -\sum_{n=1}^{\infty} C(\varepsilon) \int_{\Omega_{n}}\left(|u|^{\alpha(x)}+|v|^{\beta(x)}\right) d x \\
\geq & \frac{1}{8} \Phi(u, v)
\end{aligned}
$$

It means that assertion (i) holds.
(ii) Obviously, $J(0,0)=0$. When $t \geq 1$, by (3.1), we have

& -\int_{\mathbb{R}^{N}} \lambda\left[\frac{a(x)}{\gamma(x)} t^{\frac{\gamma(x)}{\theta_{1}}}|u|^{\gamma(x)}+\frac{b(x)}{\delta(x)} t^{\frac{\delta(x)}{\theta_{2}}}|v|^{\delta(x)}\right] d x-\int_{\mathbb{R}^{N}} F\left(x, t^{1 / \theta_{1}} u, t^{1 / \theta_{2}} v\right) d x \\
\leq & \int_{\mathbb{R}^{N}} \frac{1}{p(x)} t^{\frac{p(x)}{\theta_{1}}}\left(|\nabla u|^{p(x)}+|u|^{p(x)}\right) d x+\int_{\mathbb{R}^{N}} \frac{1}{q(x)} t^{\frac{q(x)}{\theta_{2}}}\left(|\nabla v|^{q(x)}+|v|^{q(x)}\right) d x \\
& -\int_{\mathbb{R}^{N}} \lambda\left[\frac{a(x)}{\gamma(x)} t^{\frac{\gamma(x)}{\theta_{1}}}|u|^{\gamma(x)}+\frac{b(x)}{\delta(x)} t^{\frac{\delta(x)}{\theta_{2}}}|v|^{\delta(x)}\right] d x-\int_{\mathbb{R}^{N}} t F(x, u, v) d x .

If $F$ satisfies (A0)-(A2), $\left\{\left(u_{n}, v_{n}\right)\right\}$ is a $P S$ sequence of $J$, that is $J\left(u_{n}, v_{n}\right) \rightarrow c$ which is the mountain pass level, and $J^{\prime}\left(u_{n}, v_{n}\right) \rightarrow 0$, then $\left\{\left(u_{n}, v_{n}\right)\right\}$ is bounded.
Proof. Since $1 \ll \gamma(\cdot) \ll p(\cdot), a(\cdot) \in L^{\frac{p(\cdot)}{p(\cdot)-\gamma(\cdot)}}\left(\mathbb{R}^{N}\right), 1 \ll \delta(\cdot) \ll q(\cdot), b(\cdot) \in$ $L^{\frac{q(\cdot)}{q(\cdot)-\delta(\cdot)}}\left(\mathbb{R}^{N}\right)$, we have

Since $\left\{\left\|u_{n}\right\|_{p(\cdot)}\right\}$ and $\left\{\left\|v_{n}\right\|_{q(\cdot)}\right\}$ are bounded, for any $(\varphi, \psi) \in X$, it is easy to see that the following two groups are uniformly integrable in $\mathbb{R}^{N}$,

3.2. Proof of Theorem 3.2, Motivated by the property of translation invariant for $p$-Laplacian, we get a sufficient condition for $c<J^{\infty}$. To prove Theorem 3.2, we need the following Lemma.
Lemma 3.7. If $F$ satisfies (A0)-(A2), then for any $(u, v) \in X \backslash\{(0,0)\}$, there exists a unique $t(u, v)>0$ such that
(1) $\widehat{J}\left((t(u, v))^{1 / \theta_{1}} u,(t(u, v))^{\frac{1}{\theta_{2}}} v\right)=\max _{s \in[0,+\infty)} \widehat{J}\left(s^{\frac{1}{\theta_{1}}} u, s^{1 / \theta_{2}} v\right)$,
(2) $\left((t(u, v))^{1 / \theta_{1}} u,(t(u, v))^{1 / \theta_{2}} v\right) \in \mathcal{N}$,
(3) The operator $(u, v) \mapsto t(u, v)$ is continuous from $X \backslash\{(0,0)\}$ to $(0,+\infty)$, and the operator $(u, v) \mapsto\left((t(u, v))^{\frac{1}{\theta_{1}}} u,(t(u, v))^{1 / \theta_{2}} v\right)$ is a homeomorphism from the unit sphere in $X$ to $\mathcal{N}$.

C(\varepsilon) \int_{\mathbb{R}^{N}}\left(\left|u_{n}\right|^{\alpha(x)}+\left|v_{n}\right|^{\beta(x)}\right) d x \leq \frac{\varepsilon}{2}, \quad n \geq N_{0} \tag{3.41}
\end{equation*}
$$

From (3.35), 3.40 and (3.41), we have

From $p(\cdot)$ begin periodic, for any $y_{n}, \eta_{n}$, there exist $x_{n}, \xi_{n} \in Q\left(x_{o}, A\right)$ such that

Denote $J_{1}(u, v)=$ $\Phi(u, v)-\int_{\mathbb{R}^{N}} F(x, u, v) d x$. It follows from (A2) that $F\left(x, t^{\frac{1}{\theta_{1}}} u, t^{1 / \theta_{2}} v\right) / t$ is increasing with respect to $t$. Suppose $t \in(0,1)$, it follows from (3.2) that

& =t\left\{t^{\max \left\{\frac{p^{+}}{\theta_{1}}, \frac{q^{+}}{\theta_{2}}\right\}-1} \Phi\left(u_{n}, v_{n}\right)-\int_{\mathbb{R}^{N}} F\left(x, u_{n}\left(y_{n}-x_{n}+x\right), v_{n}\left(\eta_{n}-\xi_{n}+x\right)\right) d x\right\} . \tag{3.43}

From (3.36) and the boundedness of $\left\{\left(u_{n}, v_{n}\right)\right\}$, we can see that there exists positive constants $C_{1}, C_{2}$ such that

& \leq \widehat{J}\left(t_{n}^{1 / \theta_{1}} u_{n}, t_{n}^{\frac{1}{\theta_{2}}} v_{n}\right)-\frac{\tau \varepsilon_{0} \epsilon^{\max \left\{\alpha_{o}^{+}, \beta_{o}^{+}\right\}}}{2 \max \left\{\alpha_{o}^{+}, \beta_{o}^{+}\right\}} \\
&+\int_{\mathbb{R}^{N}} \lambda\left[\frac{|a(x)|}{\gamma(x)}\left|t_{n}^{1 / \theta_{1}} u_{n}\left(y_{n}-x_{n}+x\right)\right|^{\gamma(x)}+\frac{|b(x)|}{\delta(x)}\left|t_{n}^{1 / \theta_{2}} v_{n}\left(\eta_{n}-\xi_{n}+x\right)\right|^{\delta(x)}\right] d x \\
& \leq \widehat{J}\left(u_{n}, v_{n}\right)-\frac{\tau \varepsilon_{0} \epsilon^{\max \left\{\alpha_{o}^{+}, \beta_{o}^{+}\right\}}}{4 \max \left\{\alpha_{o}^{+}, \beta_{o}^{+}\right\}}<J^{\infty} \quad \text { where } \zeta \in Q\left(x_{o}, A\right) .

This completes the proof.
3.3. Proof of Theorem 3.3. According to the [17, Theorems 2.2 and 3.2], $u$ and $v$ are locally bounded. From [10, Theorem 1.2], $u$ and $v$ are locally $C^{1, \alpha}$ continuous. Similar to the proof of [13, Proposition 2.5], we obtain that $u, v \in C^{1, \alpha}\left(\mathbb{R}^{N}\right)$, $u(x) \rightarrow 0,|\nabla u(x)| \rightarrow 0, v(x) \rightarrow 0$ and $|\nabla v(x)| \rightarrow 0$ as $|x| \rightarrow \infty$.

Note 1. Let us consider the existence of solutions for the system

(H2) For any $(s, t) \in(\mathbb{R} \times \mathbb{R}), F_{s_{i}}\left(x, \tau^{1 / \theta_{1}} s_{1}, \ldots, \tau^{1 / \theta_{n}} s_{n}\right) / \tau^{\frac{\theta_{i}-1}{\theta_{i}}}(i=1, \ldots, n)$ are increasing respect to $\tau>0$;
(H3) There is a measurable function $\widetilde{F}\left(s_{1}, \ldots, s_{n}\right)$ such that

& \quad \leq \varepsilon(R)\left\{\left|s_{i}\right|^{p_{i}(x)-1}+\left|s_{i}\right|^{p_{i}^{*}(x)-1}\right. \\
& \left.\quad+\sum_{1 \leq j \leq n, j \neq i}\left[\left|s_{j}\right|^{p_{j}(x)\left(p_{i}^{*}(x)-1\right) / p_{i}^{*}(x)}+\left|s_{j}\right|^{p_{j}^{*}(x)\left(p_{i}^{*}(x)-1\right) / p_{i}^{*}(x)}\right]\right\} \quad \text { when }|x| \geq R
