# Normal integral bases for Emma Lehmer's parametric family of cyclic quintics

#### Abstract

Résumé. Nous donnons des bases normales entières explicites pour des extensions cycliques quintiques définies par la famille paramétrée de quintiques d'Emma Lehmer.


Abstract. Explicit normal integral bases are given for some cyclic quintic fields defined by Emma Lehmer's parametric family of quintics.

## 1. Introduction

Let $n \in \mathbb{Z}$. Emma Lehmer's quintic polynomials $f_{n}(x) \in \mathbb{Z}[x]$ are defined by

$$
\begin{align*}
& f_{n}(x)=x^{5}+n^{2} x^{4}-\left(2 n^{3}+6 n^{2}+10 n+10\right) x^{3}  \tag{1.1}\\
& \quad+\left(n^{4}+5 n^{3}+11 n^{2}+15 n+5\right) x^{2}+\left(n^{3}+4 n^{2}+10 n+10\right) x+1,
\end{align*}
$$

see [4, p. 539]. Schoof and Washington [6, p. 548] have shown that $f_{n}(x)$ is irreducible for all $n \in \mathbb{Z}$. Let $\rho_{n} \in \mathbb{C}$ be a root of $f_{n}(x)$. Set $L_{n}=\mathbb{Q}\left(\rho_{n}\right)$ so that $\left[L_{n}: \mathbb{Q}\right]=5$. It is known that $L_{n}$ is a cyclic field $[6, \mathrm{p} .548]$. The discriminant $d\left(L_{n}\right)$ of $L_{n}$ has been determined by Jeannin [3, p. 76] and, as a special case of a more general result, by Spearman and Williams [7, Theorem 2], namely

d\left(L_{n}\right)=f\left(L_{n}\right)^{4}, \tag{1.2}
\end{equation*}
$$

where the conductor $f\left(L_{n}\right)$ is given by

$$
\begin{gather*}
f\left(L_{n}\right)=5^{\alpha} \prod_{\substack{p \equiv 1(\bmod 5)}}^{p \mid n^{4}+5 n^{3}+15 n^{2}+25 n+25}  \tag{1.3}\\
v_{p}\left(n^{4}+5 n^{3}+15 n^{2}+25 n+25\right) \not \equiv 0(\bmod 5)
\end{gather*}
$$

[^0]where $v_{p}(k)$ denotes the exponent of the largest power of the prime $p$ dividing the nonzero integer $k$ and
\[

\alpha= $$
\begin{cases}0, & \text { if } 5 \nmid n,  \tag{1.4}\\ 2, & \text { if } 5 \mid n .\end{cases}
$$
\]

Gaál and Pohst [2, p. 1690] have given an integral basis for $L_{n}$ when $p^{2} \nmid n^{4}+5 n^{3}+15 n^{2}+25 n+25$ for any prime $p \neq 5$. They also discuss the existence of a power integral basis for $L_{n}[2, \mathrm{p} .1695]$. It is known that
$L_{n}$ has a normal integral basis (NIB)
$\Longleftrightarrow L_{n} \subseteq \mathbb{Q}\left(e^{\frac{2 \pi i}{m}}\right)$ for some squarefree integer $m$
$\Longleftrightarrow f\left(L_{n}\right) \mid m$ for some squarefree integer $m$
$\Longleftrightarrow f\left(L_{n}\right)$ squarefree
$\Longleftrightarrow 5 \nmid n$,
see [5, p. 175]. From this point on we assume that $5 \nmid n$ so that $n$ possesses a normal integral basis. Acciaro and Fieker [1] have given an algorithm for finding a normal integral basis (when it exists) for a cyclic field of prime degree. Applying this algorithm to the 800 fields $L_{n}$ with $1 \leq n \leq 1000$ and $(n, 5)=1$ they found that 766 of these fields had a normal integral basis of the form

$$
\left\{a+\rho_{n}, a+\rho_{n}^{\prime}, a+\rho_{n}^{\prime \prime}, a+\rho_{n}^{\prime \prime \prime}, a+\rho_{n}^{\prime \prime \prime}\right\}
$$

for some $a \in \mathbb{Z}$, where $\rho_{n}, \rho_{n}^{\prime}, \rho_{n}^{\prime \prime}, \rho_{n}^{\prime \prime \prime}, \rho_{n}^{\prime \prime \prime \prime}$ are the conjugates of $\rho_{n}$. We explain this phenomenon by proving the following theorem in Section 2.

Theorem. Let $n \in \mathbb{Z}$ be such that $5 \nmid n$. Then $L_{n}$ has a normal integral basis of the form

$$
\left\{v+w \rho_{n}, v+w \rho_{n}^{\prime}, v+w \rho_{n}^{\prime \prime}, v+w \rho_{n}^{\prime \prime \prime}, v+w \rho_{n}^{\prime \prime \prime \prime}\right\} \quad(v, w \in \mathbb{Z})
$$

if and only if
$n^{4}+5 n^{3}+15 n^{2}+25 n+25$ is squarefree, $w= \pm 1, \quad v=\frac{w}{5}\left(n^{2}-\left(\frac{n}{5}\right)\right)$, where $\left(\frac{n}{5}\right)$ is the Legendre symbol modulo 5 .

It is easy to check that there are exactly 766 values of $n \in \mathbb{Z}$ such that $1 \leq n \leq 1000,5 \nmid n$ and $n^{4}+5 n^{3}+15 n^{2}+25 n+25$ is squarefree.

## 2. Proof of Theorem.

We begin by determining a cyclic permutation of the roots of $f_{n}(x)$. This was done by Schoof and Washington [6, p. 548] by means of a rational function. For our purposes we require polynomial expressions for the roots. The restriction $5 \nmid n$ is not needed in the Proposition below.

Proposition. Let $n \in \mathbb{Z}$. Let $y_{0}$ be any root of $f_{n}(x)$. Then the other four roots of $f_{n}(x)$ are

\begin{aligned}
y_{1}= & \left((n+2)^{2} y_{0}^{4}+(n+2)(n+1)\left(n^{2}+n-1\right) y_{0}^{3}\right. \\
& +\left(-2 n^{5}-14 n^{4}-43 n^{3}-76 n^{2}-80 n-39\right) y_{0}^{2} \\
& +(n+1)\left(n^{5}+8 n^{4}+29 n^{3}+60 n^{2}+71 n+36\right) y_{0} \\
& \left.+(n+2)\left(n^{3}+6 n^{2}+14 n+11\right)\right) /\left(n^{3}+5 n^{2}+10 n+7\right), \\
y_{2}= & \left((-2 n-3) y_{0}^{4}-\left(2 n^{3}+4 n^{2}+3 n+2\right) y_{0}^{3}\right. \\
& +\left(3 n^{4}+14 n^{3}+31 n^{2}+41 n+24\right) y_{0}^{2} \\
& -(n+3)\left(n^{4}+4 n^{3}+9 n^{2}+9 n+2\right) y_{0} \\
& -(n+2)(2 n+3)) /\left(n^{3}+5 n^{2}+10 n+7\right), \\
y_{3}= & \left(-(n+2)(n+1) y_{0}^{4}-\left(n^{2}+n-1\right)(n+1)^{2} y_{0}^{3}\right. \\
& +\left(2 n^{5}+12 n^{4}+33 n^{3}+54 n^{2}+53 n+23\right) y_{0}^{2} \\
& -(n+2)(n+1)\left(n^{4}+5 n^{3}+12 n^{2}+16 n+9\right) y_{0} \\
& \left.-\left(n^{5}+7 n^{4}+24 n^{3}+47 n^{2}+52 n+25\right)\right) /\left(n^{3}+5 n^{2}+10 n+7\right), \\
y_{4}= & \left((n+1) y_{0}^{4}+\left(n^{3}+2 n^{2}+3 n+3\right) y_{0}^{3}\right. \\
& -(n+2)(n+1)\left(n^{2}+n+4\right) y_{0}^{2} \\
& -\left(n^{4}+7 n^{3}+19 n^{2}+29 n+19\right) y_{0} \\
& \left.+(n+1)\left(n^{3}+5 n^{2}+11 n+9\right)\right) /\left(n^{3}+5 n^{2}+10 n+7\right) .
\end{aligned}
$$

Let $\sigma \in \operatorname{Gal}\left(f_{n}\right)$ be such that

$$
\begin{equation*}
\sigma\left(y_{0}\right)=y_{1} . \tag{2.1}
\end{equation*}
$$

Then

$$
\begin{equation*}
\sigma^{j}\left(y_{0}\right)=y_{j}, \quad j=0,1,2,3,4, \tag{2.2}
\end{equation*}
$$

and the polynomial $P_{n}(y) \in \mathbb{Q}[y]$ given by

$$
\begin{align*}
P_{n}(y)= & \left((n+2)^{2} y^{4}+(n+2)(n+1)\left(n^{2}+n-1\right) y^{3}\right.  \tag{2.3}\\
& +\left(-2 n^{5}-14 n^{4}-43 n^{3}-76 n^{2}-80 n-39\right) y^{2} \\
& +(n+1)\left(n^{5}+8 n^{4}+29 n^{3}+60 n^{2}+71 n+36\right) y \\
& \left.+(n+2)\left(n^{3}+6 n^{2}+14 n+11\right)\right) /\left(n^{3}+5 n^{2}+10 n+7\right),
\end{align*}
$$

is such that

$$
\begin{equation*}
P_{n}^{j}\left(y_{0}\right)=\sigma^{j}\left(y_{0}\right), \quad j=0,1,2,3,4 . \tag{2.3}
\end{equation*}
$$

Proof of Proposition. Using MAPLE we find that there exist polynomials $g_{n}(y), h_{n}(y), k_{n}(y), l_{n}(y) \in \mathbb{Q}[y]$ such that

$$
\begin{aligned}
& f_{n}\left(y_{1}\right)=f_{n}\left(y_{0}\right) g_{n}\left(y_{0}\right)=0 \\
& f_{n}\left(y_{2}\right)=f_{n}\left(y_{0}\right) h_{n}\left(y_{0}\right)=0 \\
& f_{n}\left(y_{3}\right)=f_{n}\left(y_{0}\right) k_{n}\left(y_{0}\right)=0 \\
& f_{n}\left(y_{4}\right)=f_{n}\left(y_{0}\right) l_{n}\left(y_{0}\right)=0
\end{aligned}
$$

where $y_{1}, y_{2}, y_{3}, y_{4}$ are defined in the statement of the Proposition. Clearly $y_{0}, y_{1}, y_{2}, y_{3}, y_{4}$ are all distinct as $y_{0}$ is a root of an irreducible quintic polynomial. Thus $y_{0}, y_{1}, y_{2}, y_{3}, y_{4}$ are the five distinct roots of $f_{n}(x)$. With $P_{n}(y)$ as defined in (2.3), we see from the definition of $y_{1}$ that

$$
\begin{equation*}
y_{1}=P_{n}\left(y_{0}\right) \tag{2.4}
\end{equation*}
$$

Another MAPLE calculation shows that

$$
\begin{aligned}
& P_{n}^{2}\left(y_{0}\right)=P_{n}\left(y_{1}\right)=y_{2} \\
& P_{n}^{3}\left(y_{0}\right)=P_{n}\left(y_{2}\right)=y_{3} \\
& P_{n}^{4}\left(y_{0}\right)=P_{n}\left(y_{3}\right)=y_{4}
\end{aligned}
$$

so that

$$
P_{n}^{j}\left(y_{0}\right)=y_{j}, \quad j=0,1,2,3,4 .
$$

With $\sigma \in \operatorname{Gal}\left(f_{n}\right)$ defined in (2.1), we see from (2.5) that

$$
P_{n}\left(y_{0}\right)=\sigma\left(y_{0}\right)
$$

Finally, as $\sigma \in \operatorname{Gal}\left(f_{n}\right)$ and $P_{n}(y) \in \mathbb{Q}[y]$, we obtain

$$
P_{n}^{2}\left(y_{0}\right)=P_{n}\left(P_{n}\left(y_{0}\right)\right)=P_{n}\left(\sigma\left(y_{0}\right)\right)=\sigma\left(P_{n}\left(y_{0}\right)\right)=\sigma^{2}\left(y_{0}\right)
$$

and similarly $P_{n}^{3}\left(y_{0}\right)=\sigma^{3}\left(y_{0}\right)$ and $P_{n}^{4}\left(y_{0}\right)=\sigma^{4}\left(y_{0}\right)$.

Proof of Theorem. Let $n \in \mathbb{Z}$ be such that $5 \nmid n$. Let $v, w \in \mathbb{Z}$. Using MAPLE we find that

$$
\begin{aligned}
D\left(v+w \rho_{n}, v\right. & \left.+w \rho_{n}^{\prime}, v+w \rho_{n}^{\prime \prime}, v+w \rho_{n}^{\prime \prime \prime}, v+w \rho_{n}^{\prime \prime \prime \prime}\right) \\
& =D\left(v+w y_{0}, v+w y_{1}, v+w y_{2}, v+w y_{3}, v+w y_{4}\right) \\
& =\mid \operatorname{det}\left(v+w y_{i+j(\bmod 5))\left._{i, j=0,1,2,3,4}\right|^{2}}\right. \\
& =w^{8}\left(5 v-w n^{2}\right)^{2}\left(n^{4}+5 n^{3}+15 n^{2}+25 n+25\right)^{4}
\end{aligned}
$$

Then, by (1.2) and (1.3), we have

$$
\left\{v+w \rho_{n}, v+w \rho_{n}^{\prime}, v+w \rho_{n}^{\prime \prime}, v+w \rho_{n}^{\prime \prime \prime}, v+w \rho_{n}^{\prime \prime \prime \prime}\right\} \text { is a NIB for } L_{n}
$$

$$
\Longleftrightarrow D\left(v+w \rho_{n}, v+w \rho_{n}^{\prime}, v+w \rho_{n}^{\prime \prime}, v+w \rho_{n}^{\prime \prime \prime}, v+w \rho_{n}^{\prime \prime \prime \prime}\right)=d\left(L_{n}\right)
$$

$$
\Longleftrightarrow w^{8}\left(5 v-w n^{2}\right)^{2}\left(n^{4}+5 n^{3}+15 n^{2}+25 n+25\right)^{4}
$$

$$
=\prod_{\underline{p} \equiv 1(\bmod 5)} p^{4}
$$

$$
p \mid n^{4}+5 n^{3}+15 n^{2}+25 n+25
$$

$$
v_{p}\left(n^{4}+5 n^{3}+15 n^{2}+25 n+25\right) \not \equiv 0(\bmod 5)
$$

$\Longleftrightarrow w^{8}=\left(5 v-w n^{2}\right)^{2}=1$ and $n^{4}+5 n^{3}+15 n^{2}+25 n+25$ squarefree
$\Longleftrightarrow w= \pm 1, \quad v=\frac{w}{5}\left(n^{2}-\left(\frac{n}{5}\right)\right), n^{4}+5 n^{3}+15 n^{2}+25 n+25$ squarefree, completing the proof of the Theorem.
